

# BRANT AND BERNHARDT PROPERTY PRIVACY POLICY

# 1. We respect your privacy

- 1.1 Brant and Bernhardt Property respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. ## 2. Collection of personal information
